Ten Percent extra allowances shall be provided for Divyang Students Terms & Conditions:

2. Scholarship is available to all SC students whose parents/ guardians income from all sources does not exceed **Rs. 2.5 Lakh** per annum who are pursuing post matriculation/post secondary (college/university) level studies in Govt. Recognized institution.
3. Upload all relevant documents like: Aadhaar, Bank details, previous year Mark sheet, original fee receipts, fee structure, income certificate & caste certificate.
4. All the children of same family/parents are also eligible subject to the income limit of the parents. Students availing any other scholarship/stipend such as merit scholarship will not be eligible for the scholarship.

 - a. National Food Security Card with 06 month transactions in their NFS card

Students who want to avail EWS Financial Assistance under ii (b) need to apply online on EWS portal and submit the hardcopy of the same to the concerned College/Institute/USS Nodal Officer for verification. Once verification is done by the concerned College/Institute/USS, the same will be submitted to the O/o DSW by the concerned Nodal Officer.

Only eligible candidate will be called by the O/o DSW for verification of documents in original.

 - b) The student who has failed in any of the subjects in any of the semesters on the last date of submission of application form.
 - c) The applicant detained in any semester examination of the course due to shortage of attendance.
 - d) The applicant penalized by the University or the institutes for any act of indiscipline during the course.

Step5: In case forget password, contact concerned officer/ faculty deputed for this purpose by the Director/ Principal.

Step6: Apply and fill up the all personal information, bank details, qualification, family details, locality & accommodation. After filling all information, click the button final submission. The edit option will not be allowed after final submission, therefore, ensure that all information is correct.

Step7: Take a print out of online submitted application and attach all requisite documents as per the guidelines and check list.

Step8: Submit duly signed print out of online submitted application along with all requisite documents to respective institute/ USS on or before **08.05.2024**.

Domicile Certificate of Delhi is required to be uploaded, if the caste (SC) certificate is not issued by the competent authority of Govt. of NCT of Delhi.
- In case of Gap up to 3 years affidavit to be uploaded on the portal.

Terms & Conditions :

- Scholarship is available to all OBC students whose parents/ guardians income from all sources does not exceed Rs. 2.5 Lakh per annum who are pursuing post matriculation/post secondary (college/university) level studies in Govt. Recognized institution.
- Regular attendance record not less than 75% in the previous year should be pre- requisite for availing scholarship.
- Students pursuing C A. /I.C.W.A. /C.S. /I.C.F.A. shall be treated as day scholars for the purpose of academic allowance. Students studying through correspondence/online courses shall not be eligible for academic allowance.
- Upload all relevant documents like Aadhaar, Bank details, previous year Mark sheet, original fee receipts, fee structure, income certificate & caste certificate.
- A certificate from the institution to the effect that the student is not getting any other scholarship/stipend.
- Date of admission in the course/commencement of class and completion of course.
- Only two boys of the same parents/guardian will be entitled to receive scholarships. This restriction will, however, not apply to girls. Accordingly, scholarships availed by girls of same parents/guardian will not adversely affect admissibility of availing scholarship upto two boys of same parents/guardian.
